# **Disaster Unemployment Assistance**

If you lost your job or had a break in your employment, self-employment, or business as a direct result
of Hurricanes Helene or Milton, you might be able to get benefit money from DUA. Disaster

Work search reporting, waiting week, and Employ Florida registration requirements for Reemployment Assistance claims have been temporarily waived for Floridians impacted by Hurricane Helene in FEMA disaster-declared counties.

If you live or work in the following DUA-eligible counties you must file your application by December 10, 2024 for Hurricane Milton.

If you live or work in the following DUA-eligible counties you must file your application by December 2, 2024 for Hurricane Helene.

- Governor Ron DeSantis activated the Florida Small Business Emergency Bridge Loan Program, making \$50 million available for businesses impacted by Hurricane Milton. Florida small business owners in need of assistance, including sole proprietors, are encouraged to visit <a href="www.FloridaJobs.org/EBL">www.FloridaJobs.org/EBL</a> to apply for the Florida Small Business Emergency Bridge Loan Program. The program provides short-term, zero-interest loans to small businesses that experienced economic injury or physical damage due to Hurricane Milton. Interested applicants can apply now through December 4, 2024, or until all available funds are expended.

The U.S. Small Business Administration (SBA) has opened a Business Recovery Center (BRC) in Hillsborough County to provide one-on-one assistance with submitting disaster loan applications for Florida businesses impacted by Hurricanes Helene and Milton.

SBA Customer Service Representatives will be available to answer questions about the disaster loan program and assist business owners in completing their applications. The BRC plays a critical role during disasters, assisting businesses in recovering from physical, inventory, and economic losses by offering low-interest loans with repayment plans of up to 30 years.

The Hillsborough County BRC is located at the Entrepreneur Collaborative Center (ECC), 2101 E. Palm Ave., Tampa, FL 33605. The BRC is open Monday to Friday, 8 a.m. to 5 p.m.; Saturday, 9 a.m. to 2 p.m. The center is closed on Sunday.

Free parking is available across Palm Avenue.

- **Damage Reporting:** The Hurricane Damage Reporting Form is designed to help Hillsborough County officials connect residents with local recovery resources.

Homeowners and owners/renters of agricultural properties, nonprofits, and houses of worship should complete this form, which will help County staff communicate resident needs to local partners, such as American Red Cross, Feeding Tampa Bay, Metropolitan Ministries, Rebuilding Together Tampa Bay, and more. Residents who need assistance in completing the form should call (833) HC-STORM or 833-427-8676, the County's Customer Service & Support storm information line. This County assessment form IS NOT

a Federal Emergency Management Agency (FEMA) application. To register with FEMA, visit DisasterAssistance.gov. Please keep in mind that completing this form DOES NOT replace a business or homeowner's insurance claim, nor does it serve as an application for resources.

 Hillsborough County Comfort Stations: Hillsborough County and the City of Tampa opened six comfort stations to help residents affected by Hurricane Helene. Two comfort stations are in the City of Tampa and four other locations are in Town 'N Country, Apollo Beach, and Ruskin.

The comfort stations offer showers, restrooms, ice, washers, and dryers for laundry, and charging stations for phones, laptops, and other communications devices. Hot food or boxed meals will be available from approximately 11:30 a.m. - 12:30 p.m. for lunch and 5:30 p.m. - 6:30 p.m. for dinner.

- Storm debris cleanup: Hillsborough County will be collecting storm debris from County neighborhoods most heavily affected by Hurricane Helene. Residents in the County's collection areas impacted by flooding should place debris curbside without blocking the roadway or storm drains. To ensure smooth collection, materials should be separated into three categories: yard waste, damaged household appliances, and construction and demolition debris to include furniture, drywall, carpet, and fencing. Bagged waste and household hazardous waste, such as paint or car batteries, will not be accepted as part of this storm-related pickup. To learn more, visit the pickup map.
- Hurricane Agricultural Impacts Survey Available: The University of Florida Institute of Food and
  Agricultural Sciences (UF/IFAS) is conducting a survey to determine agricultural damages from
  Hurricanes Helene and Milton. Survey results will be used to estimate production losses and inform
  local, state, and federal decision-making related to disaster declaration, response, and relief. See

Representatives from FEMA, the Florida Small Business Administration (SBA), and stakeholders will be present to assist residents who want to file a FEMA application for Individual Assistance through the Individual and Households Program (IHP) for Hurricane Helene.

 The Hillsborough County Office of Emergency Management, Florida Department of Emergency Management (FDEM), and the Federal Emergency Management Agency (FEMA) are opening a Disaster Recovery Center (DRC) for individuals, families, and businesses impacted by Hurricanes Milton, Helene, and Debby.

The center will be open daily from 9 a.m.- 6 p.m. until further notice at the Arthenia L. Joyner University Area Community Library at 13619 N. 22nd St., Tampa.

The DRC is open to individuals, families, businesses, and nonprofits seeking assistance or needing help in completing applications after being impacted by Hurricanes Milton, Helene, and Debby. FEMA representatives will be in attendance to assist.

Additionally, FEMA declared that residents in Hillsborough County who were impacted by Hurricanes Milton, Helene, and Debby can apply for aid through the Individuals and Households Program (IHP).

The program provides financial and direct services to eligible individuals and households affected by Hurricanes Milton, Helene, and Debby. The assistance is intended to meet basic needs and supplement disaster recovery efforts. Residents who need long-term housing are encouraged to apply for individual assistance with FEMA as soon as possible.

 Impacted Hillsborough County residents can apply for the FEMA assistance if they have uninsured or underinsured necessary expenses and serious needs, according to FEMA. However, the IHP assistance is not a substitute for insurance and cannot compensate for all losses caused by a disaster.

What does FEMA assistance for the IHP include?

- Funds for temporary housing while you are unable to live in your home, such as rental assistance, or reimbursement for hotel costs
- Funds to support the repair or replacement of owner-occupied homes that serve as the household's primary residence, including privately-owned access routes, such as driveways, roads, or bridges
- A temporary housing unit when you are not able to use rental assistance due to a lack of available housing resources
- Funds for hazard mitigation assistance to help eligible homeowners repair or rebuild stronger, more durable homes
- o Funds for other uninsured or under-insured disaster-caused expenses and serious needs
